



## **COMPULSORY CONSENT FORM**

### **Medical Consent**

I confirm that I am/ my child is physically able to participate in their relevant training activity. I have informed the club of any medical conditions for my child/ myself and I will ensure to inform the club of any changes in the future. I confirm that I give consent for all necessary medical treatments to be administered as seen fit by paramedics in the event of injury/ illness.

In signing this agreement, I declare that I am aware of the element of risk involved with sporting activity. I understand that Revolution staff will take precautions to prevent accidents, in line with British Gymnastics guidance and internal risk assessments.

### **Disability/ Additional Needs**

If you/ your child has a disability or additional needs that the club should be made aware of, please request a specific form from our reception team so that the information can be processed appropriately.

### **Code Of Conduct / Welfare Notice**

I confirm that I have read through the club's code of conduct and policies (found on the club website) and I/ my child understand and agree to abide by those rules. Failing to adhere to the code of conduct will result in disciplinary action and the position with the club may be terminated.

Revolution Staff are fully trained to physically support/ spot the participants during training session. There are toilets in the gymnasium that participants can use during sessions, though under 6yrs we require parents to stay on site for children to use the public toilets with a parent/guardian.

### **Refund/ Cancellation Policy**

In order to cancel your membership with the club, you must notify us via email ([revolutiongymnastics@outlook.com](mailto:revolutiongymnastics@outlook.com)) or request to drop your class via your IclassPro account. All cancellations are subject to 1 months' notice payment following the cancellation date.

There will no reimbursements made, should the facility have to close due to weather conditions, circumstances outside of the club's control, absence through holiday or injury (which has not occurred whilst at Revolution Gymnastics) or being refused entry due to lateness.

*(Late is defined as 5 minutes past the start of the session. Revolution staff reserve the right to turn away participants who arrive late.)*

## **Annual Membership Fee**

Annual membership is the compulsory fee paid to the club in September which lasts until September in the following year. It is your responsibility to register this insurance with British Gymnastics via their website, for which there is a link provided on our club website under 'Prices/ Fees'.

A proportion of this fee is payable to British Gymnastics (via the club), the West Midlands Amateur Gymnastics Association and the remainder towards club funds. This fee will be debited automatically on 1st September each year.

Annual membership fees are subject to yearly increases inline with British Gymnastics, WMAGA and inflation.

## **Film & Photography Consent**

I am aware that photographs and video footage may be taken during sessions for coach education, training feedback and promotional purposes. I give consent for me/ my child to appear in photographs and video footage.

## **Collecting Late**

To allow our classes to run smoothly we rely on members to be collected on time, if a participant is not collected on time there will be a £5 charge added to your account for every 5 minutes you are late.

If you are late picking up your child you will need to go to the main reception desk where they will be responsible for signing out participants who were not collected on time.

Persistent lateness when picking up may result in disciplinary action.

## **Failed Payments/ Admin Charge**

If your monthly payment fails due to insufficient funds and is not paid within 7 days, there will be an automatic £5 administrative charge to your account.
